The USTA Texas Section will reimburse the entry fees (including the processing fees) for anyone entering an Adult, Senior or Super Senior division for their first Texas section sanctioned tournament. This offer is good until the budgeted monies are depleted and for tournaments scheduled:

January 1, 2018 – December 31, 2018;

and the reimbursement forms are received by **December 15, 2018.**

(Feel free to submit the form early to reserve your place in the budgeted monies.)

Rules for their reimbursement:

- 1. Must be/have been a USTA Texas League tennis player - and**
- 2. Must play in their first USTA Texas sanctioned tournament - and**
- 3. Must be in an Adult, Senior or Super Senior division (not just ages!)**
These divisions are: Levels divisions (2.5-5.0); Age divisions: Men (25-85); Women (30-80); Husband/Wife; Mother/Daughter; Father/Son; &/or Senior: Mother/Daughter or Father/Son – **and**
- 4. Must play in a Texas sanctioned tournament for the 2018 calendar year - and**
- 5. Must submit the reimbursement form before the budgeted monies are depleted, but no later than Dec. 15, 2018.**

Forms will be accepted for later scheduled tournaments (if still within the 2018 calendar) to reserve a place in the allocated budget monies, but reimbursement will not be disbursed until after the completion of the registered tournament.
